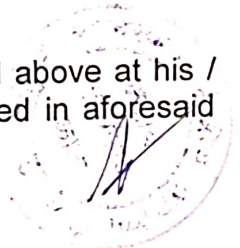

9. The EMD of the unsuccessful bidder will be returned on the closure of the e-auction sale proceedings through RTGS/NEFT without interest.
10. The sale is subject to confirmation by the Bank. If the borrower / guarantor pays the amount due to the Bank in full before date of sale, no sale will be conducted.
11. Prospective bidders are advised to peruse the RC copies of vehicle with the Bank and other records at RTO before bidding.
12.
